Exploration Highlights & News

(Dec 4, 2025) - **Carmen Schmitt, Inc.,** based in Great Bend, Kansas, has discovered new oil reserves in the Marmaton Group at the #1-11 RJ Farms site, located in approximately SE NE SW NW of section 11-28s-24W in Ford County This wildcat discovery is producing crude oil from the Pawnee Limestone formation, situated nearly two and a half miles south of recognized Marmaton oil production in the Willroads field. The RJ Farms well was drilled to a total depth of 5,350 feet. Completion details have not yet been released. The new unnamed pool lies approximately nine miles west of Ford, Kansas. (ref: API 15-057-21106).

The initial discovery well in the Willroads field, #1 Barngrover, was drilled by Tennessee Gas & Oil in 1960. Located in the SW/4 section 26-27s-24W, it produced nearly 115,415 barrels of oil from the Marmaton Group between 1960 and 1995. The Willroads field also produces natural gas from the Chase, Morrow, and Mississippian formations.

(Nov 20, 2025) - **Ritchie Exploration, Inc.**, of Wichita, Kansas, has discovered Mississippian oil reserves at the #1 Brad-shaw 9D, spotted in approximately SW NE NW SE of section 9-8s-34W in Thomas County. The wildcat well was drilled nearly one mile northeast of Marmaton and Cherokee oil production in the Morgan pool (established in 1995). Rotary total depth is 4,750 feet. Completion details are currently confidential. The field is unnamed presently. The field area is about one mile south and 3 miles west of Colby, Kansas. (ref: API 15-193-21151)

(Nov 20, 2025) - **Castle Resources, Inc.**, of Russell, Kansas, has recovered good shows of oil in the Lan-sing- Kansas City C zone at a wash down of the #1 Stackhouse OWWO, approximately NW NE NW SW in section 13-12s-19W in Ellis County. The top of the C zone was reached at 3,518 feet, with total depth obtained at 3,852 feet. After acid treatments, the well was swab tested at the rate of 6 barrels of fluid per hour, 80% oil. The operator is currently pump testing the well. The new unnamed pool opener lies nearly one mile northeast of the Ernie pool (established in 2009, LKC Oil) and is one-quarter mile north of Hyacinth, Kansas. (ref: API 15-051-26332-0001)

(Nov 13, 2025) - The Kansas Geological Survey is celebrating the opening of its newly renovated Watney CORELAB on the University of Kansas campus in Lawrence, Kansas. The expansion more than doubles the space dedicated to preserving and storing the state's extensive collection of rock cores maintained by the Kansas Geological Survey. Additionally, it more than doubles the laboratory space available for scientists and engineers to analyze these materials. This celebration marks a significant milestone in the institution's goal of becoming the premier hub for rock core and critical materials analysis in the Midcontinent. The CORELAB is named in honor of the late Lynn Watney, who worked 43 years as an executive Senior Scientific Fellow and was a steward of the state's core collection.

(Nov 6, 2025) - A **Kansas Geological Society's Nomenclature Committee** meeting was held in Wichita, Kansas on October 29, 2025, whereby, in association with the Kansas Corporation Commission (KCC) and the Kansas Geological Survey, they recognized and named five new oil fields in Kansas. The new field discoveries are based on completed wells reported in September 2025.

The #1-36 Smith is in approximately NE SW SE NW in section 36-21s-38W, about seventeen miles north and 6 miles east of the town of Kendall, Kansas. The well was drilled to a total depth of 5,190 feet by Lighthouse Drilling tools. Well completion information remains confidential by the operator. The new pool has been named "West Hibbard". (Ref: API 15-093-22023)

Mull Drilling's #1-36 Smith is a remote wildcat located nearly five miles north of the prolific "Patterson" pool, which was discovered by Stanolind Oil & Gas Company (formerly Pan American Petroleum) in September 1941. The pool discovery well, #1 Gates O. Patterson, was completed with a potential 3,964 barrels of oil per day (depthograph), with no water, in the SE/4 of section 23-22s-38W. The well produced 38.4-degree gravity crude from perforations between 4,740 and 4,752 feet. It produced 577,263 barrels of oil from 1941 to 1958 and is still producing today. (Ref: API 15-093-00040)

The nearest production site is about three-quarters of a mile to the south in the LO-RI pool, which has yielded over 31,000 barrels of oil from the LKC and Marmaton formations from two wells since 2003. (Sept 25, 2025) - **Murfin Drilling Company**, of Wichita, Kansas, reports the discovery of new Lansing - Kansas City oil reserves at their #1-20 Vogler, located in approximately S/2 NE SE SE in section 20-11s-33W in Logan County.
